in may of 1939 the cuban government turned away the hamburg america line s ms st louis which carried more than 900 hopeful jewish refugees escaping nazi germany the passengers subsequently sought safe haven in the united states but were rejected once again and the st louis had to embark on an uncertain

return voyage to europe finally the st louis passengers found refuge in four western european countries but only the 288 passengers sent to england evaded the nazi grip that closed upon continental europe a year later over the years the fateful voyage of the st louis has come to symbolize u s indifference to the plight of european jewry on the eve of world war ii although the episode of the st louis is well known the actual fates of the passengers once they disembarked slipped into historical obscurity prompted by a former passenger s curiosity sarah ogilvie and scott miller of the united states holocaust memorial museum set out in 1996 to discover what happened to each of the 937 passengers their investigation spanning nine years and half the globe took them to unexpected places and produced surprising results *refuge denied* chronicles the unraveling of the mystery from los angeles to havana and from new york to jerusalem some of the most memorable stories include the fate of a young toolmaker who survived initial selection at auschwitz because his glasses had gone flying moments before and a jewish child whose apprenticeship with a baker in wartime france later translated into the establishment of a successful business in the united states unfolding like a compelling detective thriller *refuge denied* is a must read for anyone interested in the holocaust and its impact on the lives of ordinary people

a true story of hundreds of jewish refugees and the sea journey they hoped would save them on may 13 1939 the eve of the second world war the ms st louis left port in hamburg germany headed for havana cuba among the ship s passengers were more than six hundred jews attempting to escape nazi rule but most of the visas the passengers had purchased turned out to be fake and after several days in limbo in havana s harbor the ship s captain turned back for europe canadian and american activists petitioned their governments to accept the refugees on humanitarian grounds but to no avail on its return the ship would distribute its passengers among european countries and over the course of the war an estimated 250 would die in nazi concentration camps this volume in the stories of our past series is illustrated with photos and sidebar features on the voyage glimpses into the lives of passengers a look at canada s postwar refugee policy and memorials dedicated to preserving the story of this tragic event in canadian immigration history

this book examines the history of american immigration a critical topic in 21st century america particularly those lesser known stories of immigrants who were denied entrance into the states or detained for security reasons

the extraordinary true story of the st louis a german ship that in 1939 carried jews away from hamburg and into an unimaginable ordeal the new york times on may 13 1939 the luxury liner st louis sailed from hamburg one of the last ships to leave nazi germany before world war ii erupted aboard were 937 jews some had already been in concentration camps who believed they had bought visas to enter cuba the voyage of the damned had begun before the st louis was halfway across the atlantic a power struggle ensued between the corrupt cuban immigration minister who issued the visas and his superior president bru the outcome the refugees would not be allowed to land in cuba in america the brown shirts were holding nazi rallies in madison square garden anti semitic father coughlin had an audience of fifteen million back in germany plans were being laid to implement the final solution and aboard the st louis 937 refugees awaited the decision that would determine their fate gordon thomas and max morgan witts have re created history in this meticulous reconstruction of the voyage of the st louis every word of their account is true the german high command s ulterior motive in granting permission for the mission of mercy the confrontations between the refugees and the german crewmen the suicide attempts among the passengers and the attitudes of those who might have averted the catastrophe but didn t in

reviewing the work the new york times was unequivocal an extraordinary human document and a suspense story that is hard to put down but it is more than that it is a modern allegory in which the ss st louis becomes a symbol of the ss planet earth in this larger sense the book serves a greater purpose than mere drama

this is the newly revised and updated edition of donna demac s study of the increasing threat of censorship in america the first edition 1988 was published by pen american center the u s branch of the international writers organization

november 9th 1938 is widely seen as a violent turning point in nazi germany s assault on the jews an estimated 400 jews lost their lives in the anti semitic pogrom and more than 30 000 were imprisoned or sent to concentration camps where many were brutally mistreated thousands more fled their homelands in germany and austria shocked by what they had seen heard and experienced what they took with them was not only the pain of saying farewell but also the memory of terrible scenes attacks by mobs of drunken nazis public humiliations burning synagogues inhuman conditions in overcrowded prison cells and concentration camp barracks the reactions of neighbours and passersby to these barbarities ranged from sympathy and aid to scorn mockery and abuse in 1939 the harvard sociologist edward hartshorne gathered eyewitness accounts of the kristallnacht from hundreds of jews who had fled but hartshorne joined the secret service shortly afterwards and the accounts he gathered were forgotten until now these eyewitness testimonies published here for the first time with a foreword by saul friedländer the pulitzer prize historian and holocaust survivor paint a harrowing picture of everyday violence in one of europe s darkest moments this unique and disturbing document will be of great interest to anyone interested in modern history nazi germany and the historical experience of the jews

the denial of the holocaust has no more credibility than the assertion that the earth is flat yet there are those who insist that the death of six million jews in nazi concentration camps is nothing but a hoax perpetrated by a powerful zionist conspiracy sixty years ago such notions were the province of pseudohistorians who argued that hitler never meant to kill the jews and that only a few hundred thousand died in the camps from disease they also argued that the allied bombings of dresden and other cities were worse than any nazi offense and that the germans were the true victims of world war ii for years those who made such claims were dismissed as harmless cranks operating on the lunatic fringe but as time goes on they have begun to gain a hearing in respectable arenas and now in the first full scale history of holocaust denial deborah lipstadt shows how despite tens of thousands of living witnesses and vast amounts of documentary evidence this irrational idea not only has continued to gain adherents but has become an international movement with organized chapters independent research centers and official publications that promote a revisionist view of recent history lipstadt shows how holocaust denial thrives in the current atmosphere of value relativism and argues that this chilling attack on the factual record not only threatens jews but undermines the very tenets of objective scholarship that support

our faith in historical knowledge thus the movement has an unsuspected power to dramatically alter the way that truth and meaning are transmitted from one generation to another

american courts routinely hand down harsh sentences to individual convicts but a very different standard of justice applies to corporations too big to jail takes readers into a complex compromised world of backroom deals for an unprecedented look at what happens when criminal charges are brought against a major company in the united states federal prosecutors benefit from expansive statutes that allow an entire firm to be held liable for a crime by a single employee but when prosecutors target the goliaths of the corporate world they find themselves at a huge disadvantage the government that bailed out corporations considered too economically important to fail also negotiates settlements permitting giant firms to avoid the consequences of criminal convictions presenting detailed data from more than a decade of federal cases brandon garrett reveals a pattern of negotiation and settlement in which prosecutors demand admissions of wrongdoing impose penalties and require structural reforms however those reforms are usually vaguely defined many companies pay no criminal fine and even the biggest blockbuster payments are often greatly reduced while companies must cooperate in the investigations high level employees tend to get off scot free the practical reality is that when prosecutors face hydra headed corporate defendants prepared to spend hundreds of millions on lawyers such agreements may be the only way to get any result at all too big to jail describes concrete ways to improve corporate law enforcement by insisting on more stringent prosecution agreements ongoing judicial review and greater transparency

the investigation of lashawn tompkins s murder seems straightforward enough upon his release from death row the ex drug dealer returned to his old neighborhood where he was gunned down on his mother s doorstep just another case of turf warfare at least that s what it looks like on the surface to seattle investigator j p beaumont who s been handed the assignment under the strictest confidence but as beau starts digging the situation becomes more complicated than he d thought it appears that lashawn really had turned over a new leaf at the king street mission and his murder was premeditated someone had targeted the man for death meanwhile beau s lover and fellow cop mel soames is given her own hush hush investigation a routine check on registered sex offenders has revealed a disturbing pattern they re dying off at an alarming rate and not all due to natural causes details of the latest death suggest an inside job and mel isn t letting this go suddenly mel s investigation becomes entangled with beau s and the two begin to uncover a nightmarish conspiracy that could involve people in high places including their own top brass

in 1882 congress passed a chinese exclusion law that barred the entry of chinese laborers for ten years the chinese thus became the first people to be restricted from immigrating into the united states on the basis of race exclusion was renewed in 1892 and 1902 and finally made permanent in 1904 only in 1943 did congress rescind all the chinese exclusion laws as a gesture of goodwill towards china an ally of the united states during world war ii entry denied is a collection of essays on how the chinese exclusion laws were implemented and how the chinese as individuals and as a community in the u s mobilized to mitigate the restrictions imposed upon them it is the first book in english to rely on chinese language sources to explore the exclusion era in chinese american history

the price of freedom denied shows that contrary to popular opinion ensuring religious freedom for all reduces violent religious persecution and conflict others have suggested that restrictions on religion are necessary to maintain order or preserve a peaceful religious homogeneity brian j grim and roger finke show that restricting religious freedoms is associated with higher levels of violent persecution relying on a new source of coded data for nearly 200 countries and case studies of six countries the book offers a global profile of religious freedom and religious persecution grim and finke report that persecution is evident in all regions and is standard fare for many they also find that religious freedoms are routinely denied and that government and the society at large serve to restrict these freedoms they conclude that the price of freedom denied is high indeed

us is a story about guilt individual guilt collective and societal guilt along with its co joined partner hypocrisy it s an exploration of a denied reality that s a reality concealed by subjective propaganda and opinion it s an american story with universal resonance everard explores the guilt that surrounds the adult entertainment industry the guilt within the industry and the guilt that accompanies the consumption of the products and services it produces the book is an

filmmaker errol morris offers his perspective on the world and his powerful belief in the necessity of truth in 1972 philosopher of science thomas kuhn threw an ashtray at errol morris this book is the result at the time morris was a graduate student now we know him as one of the most celebrated and restlessly probing filmmakers of our time the creator of such classics of documentary investigation as the thin blue line and the fog of war kuhn meanwhile was and posthumously remains a star in his field the author of the structure of scientific revolutions a landmark book that has sold well over a million copies and introduced the concept of paradigm shifts to the larger culture and morris thought the idea was bunk the ashtray tells why and in doing so it makes a powerful case for morris's way of viewing the world and the centrality to that view of a fundamental conception of the necessity of truth for me morris writes truth is about the relationship between language and the world a correspondence idea of truth he has no patience for philosophical systems that aim for internal coherence and disdain the world itself morris is after bigger game he wants to establish as clearly as possible what we know and can say about the world reality history our actions and interactions it's the fundamental desire that animates his filmmaking whether he's probing robert mcnamara about vietnam or the oddball owner of a pet cemetery truth may be slippery but that doesn't mean we have to grease its path of escape through philosophical evasions rather morris argues powerfully it is our duty to do everything we can to establish and support it in a time when truth feels ever more embattled under siege from political lies and virtual lives alike the ashtray is a bracing reminder of its value delivered by a figure who has over decades uniquely earned our trust through his commitment to truth no morris fan should miss it

obsession murder and justice denied

based on recently discovered documents the jews should keep quiet reassesses the hows and whys behind the franklin d roosevelt administration's fateful policies during the holocaust rafael medoff delves into difficult truths with fdr's consent the administration deliberately suppressed european immigration far below the limits set by u.s. law his administration also refused to admit jewish refugees to the u.s. virgin islands dismissed proposals to use empty liberty ships returning from europe to carry refugees and rejected pleas to drop bombs on the railways leading to auschwitz even while american planes were bombing targets only a few miles away actions that would not have conflicted with the larger goal of winning the war what motivated fdr medoff explores the sensitive question of the president's private sentiments toward jews unmasking strong parallels between roosevelt's statements regarding jews and asians he connects the administration's policies of excluding jewish refugees and interning japanese americans the jews should keep quiet further reveals how fdr's personal relationship with rabbi stephen s. wise american jewry's foremost leader in the 1930s and 1940s swayed the u.s. response to the holocaust documenting how

roosevelt and others pressured wise to stifle american jewish criticism of fdr s policies medoff chronicles how and why the american jewish community largely fell in line with wise ultimately medoff weighs the administration s realistic options for rescue action which if taken would have saved many lives

from bestselling author david nasaw a sweeping new history of the one million refugees left behind in germany after wwii in may 1945 after german forces surrendered to the allied powers millions of concentration camp survivors pows slave laborers political prisoners and nazi collaborators were left behind in germany a nation in ruins british and american soldiers attempted to repatriate the refugees but more than a million displaced persons remained in germany jews poles estonians latvians lithuanians ukrainians and other eastern europeans who refused to go home or had no homes to return to most would eventually be resettled in lands suffering from postwar labor shortages but no nation including the united states was willing to accept more than a handful of the 200 000 to 250 000 jewish men women and children who remained trapped in germany when in june 1948 the united states congress passed legislation permitting the immigration of displaced persons visas were granted to sizable numbers of war criminals and nazi collaborators but denied to 90 of the jewish displaced persons a masterwork from acclaimed historian david nasaw the last million tells the gripping but until now hidden story of postwar displacement and statelessness and of the last million as they crossed from a broken past into an unknowable future carrying with them their wounds their fears their hope and their secrets here for the first time nasaw illuminates their incredible history and shows us how it is our history as well
