the u s Dmexico border is frequently presented by contemporary media as a violent and dangerous place but that is not a new perception for decades the border has been constructed as a topographic metaphor for all forms of illegality in which an ineffable link between space and violence is somehow assumed the sociological and cultural implications of violence have recently emerged at the forefront of academic discussions about the border and yet few studies have been devoted to one of its most disturbing manifestations gender violence this book analyzes this pervasive phenomenon including the femicides in ciudad ju rez that have come to exemplify at least for the media its most extreme manifestation contributors to this volume propose that the study of gender motivated violence requires interpretive and analytical strategies that draw on methods reaching across the divide between the social sciences and the humanities through such an interdisciplinary conversation the book examines how such violence is represented in oral narratives newspaper reports films and documentaries novels tv series and legal discourse it also examines the role that the media have played in this process as well as the legal initiatives that might address this pressing social problem together these essays offer a new perspective on the implications of and connections between gendered forms of violence and topics such as mechanisms of social violence the micro social effects of economic models the asymmetries of power in local national and transnational configurations and the particular rhetoric aesthetics and ethics of discourses that represent violence

five freshly decapitated human heads are thrown onto a crowded dance floor in western mexico a mexican drug cartel dismembers the body of a rival and then stitches his face onto a soccer ball these are the sorts of grisly tales that dominate the media infiltrate movies and tv shows and ultimately shape americans perception of mexico as a dangerous and scary place overrun by brutal drug lords without a doubt the drug war is real in the last six years over 60 000 people have been murdered in narco related crimes but there is far more to mexico s story than this gruesome narrative would suggest while thugs have been grabbing the headlines mexico has undergone an unprecedented and under publicized political economic and social transformation in her groundbreaking book two nations indivisible shannon k o neil argues that the united states is making a grave mistake by focusing on the politics of antagonism toward mexico rather we should wake up to the revolution of prosperity now unfolding there the news that isn t being reported is that over the last decade mexico has become a real democracy providing its citizens a greater voice and opportunities to succeed on their own side of the border armed with higher levels of education upwardly mobile men and women have been working their way out of poverty building the largest most stable middle class in mexico s history this is the mexico americans need to get to know now more than ever the two countries are indivisible it is past time for the u s to forge a new relationship with its southern neighbor because in no uncertain terms our future depends on it

the twin cities of nogales arizona and nogales sonora for years straddled an indistinct border but with the maquiladora industry a crackdown against undocumented immigrants and drug smuggling neither nogales will ever be the same cover

the first transnational history of the u s mexico border line in the sand details the dramatic transformation of the western u s mexico border from its creation at the end of the mexican american war in 1848 to the emergence of the modern boundary line in the first decades of the twentieth century in this sweeping narrative rachel st john explores how this boundary changed from a mere line on a map to a clearly marked and heavily regulated divide between the united states and mexico focusing on the desert border to

the west of the rio grande this book explains the origins of the modern border and places the line at the center of a transnational history of expanding capitalism and state power in the late nineteenth and early twentieth centuries moving across local regional and national scales st john shows how government officials native american raiders ranchers railroad builders miners investors immigrants and smugglers contributed to the rise of state power on the border and developed strategies to navigate the increasingly regulated landscape over the border s history the u s and mexican states gradually developed an expanding array of official laws ad hoc arrangements government agents and physical barriers that did not close the line but made it a flexible barrier that restricted the movement of some people goods and animals without impeding others by the 1930s their efforts had created the foundations of the modern border control apparatus drawing on extensive research in u s and mexican archives line in the sand weaves together a transnational history of how an undistinguished strip of land became the significant and symbolic space of state power and national definition that we know today

why do mexicans migrate to the united states is there a typical mexican migrant beginning in the 1970s survey data indicated that the average migrant was a young unmarried man who was poor undereducated and in search of better employment opportunities this is the general view that most americans still hold of immigrants from mexico on the move argues that not only does this view of mexican migrants reinforce the stereotype of their undesirability but it also fails to capture the true diversity of migrants from mexico and their evolving migration patterns over time using survey data from over 145 000 mexicans and in depth interviews with nearly 140 mexicans filiz garip reveals a more accurate picture of mexico u s migration in the last fifty years there have been four primary waves a male dominated migration from rural areas in the 1960s and 70s a second migration of young men from socioeconomically more well off families during the 1980s a migration of women joining spouses already in the united states in the late 1980s and 90s and a generation of more educated urban migrants in the late 1990s and early 2000s for each of these four stages garip examines the changing variety of reasons for why people migrate and migrants perceptions of their opportunities in mexico and the united states looking at mexico u s migration during the last half century on the move uncovers the vast mechanisms underlying the flow of people moving between nations

stemming from four years of ethnographic research media analysis of over 750 national news articles published in the 2010s and decades of the author's professional and personal immersion in the rio grande valley of south texas rhetoric and reality illuminates a place at the heart of our national conversation the us mexico border k jill fleuriet contrasts the rhetoric of national political and media discourse with that of local border leaders in

economics health care politics education law enforcement philanthropy and activism as she deconstructs the common narrative of a border in need of external intervention to control corruption poverty sickness and violence fleuriet engagingly illustrates the range of regional organizing local development strategies and community responses in the borderlands that ultimately situate the rio grande valley as the true north of the u s national compass where the valley goes the rest of the country soon will follow rhetoric and reality asks us to question our own assumptions especially about those areas that drive national decisions about resource allocation economic development and national security rhetoric and reality is an important ethnographic study of the deeply misunderstood increasingly vilified rio grande valley located on the texas mexico border fleuriet presents a balanced counter narrative that that shows the region as one of growth innovation complexity and rich with meaning rhetoric and reality is an excellent example of place based reflexive scholarship appropriate for use in courses on border theory applied anthropology and research methods written clearly and crisply with a wide readership in mind rhetoric and reality is mandatory reading for those wanting to better understand the us mexico border region and the people who live there margaret a graham professor and chair the university of texas rio grande valley usa this is an important book as it describes life in the rio grande valley rather than on the border the notion of the border as an open range in need of external help is challenged as the author illustrates the wide range of leadership and programmatic change occurring in the rio grande valley roberto r alvarez professor emeritus of ethnic studies university of california san diego usa

the border region of the sonoran desert which spans southern arizona in the united states and northern sonora mexico has attracted national and international attention but what is less discussed in national discourses is the impact of current border policies on the native peoples of the region there are twenty six tribal nations recognized by the u s federal government in the southern border region and approximately eight groups of indigenous peoples in the united states with historical ties to mexico the yaqui the o odham the cocopah the kumeyaay the pai the apaches the tiwa tigua and the kickapoo divided peoples addresses the impact border policies have on traditional lands and the peoples who live there whether environmental degradation border patrol harassment or the disruption of traditional ceremonies anthropologist christina leza shows how such policies affect the traditional cultural survival of indigenous peoples along the border the author examines local interpretations and uses of international rights tools by native activists counterdiscourse on the u s mexico border and challenges faced by indigenous border activists when communicating their issues to a broader public through ethnographic research with grassroots indigenous activists in the region the author reveals several layers of division the division of indigenous peoples by the physical u s mexico border the divisions that exist between indigenous perspectives and mainstream u s perspectives regarding the border and the traditionalist nontraditionalist split among indigenous nations within the united states divided peoples asks us to consider the possibilities for challenging settler colonialism both in sociopolitical movements and in scholarship about indigenous peoples and lands

jusionyte explores the sister towns bisected by the border from many angles in this illuminating and poignant exploration of a place and situation that are little discussed yet have significant implications for larger political discourse publishers weekly starred review emergency responders on the us mexico border operate at the edges of two states they rush patients to hospitals across country lines tend to the broken bones of migrants who jump over the wall and put out fires that know no national boundaries paramedics and firefighters on both sides of the border are tasked with saving lives and preventing disasters in the harsh terrain at the center of divisive national debates ieva jusionyte s firsthand experience as an emergency responder provides the background for her gripping examination of the politics of injury and rescue in the militarized region surrounding the us mexico border operating in this area firefighters and paramedics are torn between their mandate as frontline state actors and their responsibility as professional rescuers

spanning three hundred years and the colonial regimes of spain mexico and the united states maurice s crandall s sweeping history of native american political rights in what is now new mexico arizona and sonora demonstrates how indigenous communities implemented subverted rejected and indigenized colonial ideologies of democracy both to accommodate and to oppose colonial power focusing on four groups pueblos in new mexico hopis in northern arizona and tohono o odhams and yaquis in arizona sonora crandall reveals the ways indigenous peoples absorbed and adapted colonially imposed forms of politics to exercise sovereignty based on localized political economic and social needs using sources that include oral histories and multinational archives this book allows us to compare spanish mexican and american conceptions of indian citizenship and adds to our understanding of the centuries long struggle of indigenous groups to assert their sovereignty in the face of settler colonial rule

the us mexican borderlands form the region where the united states and latin america have interacted with the greatest intensity this work addresses the protracted conflict rooted in the vast difference in power between mexico and its northern neighbor each of the seven parts explores a key issue in borderlands studies

making the chinese mexican is the first book to examine the chinese diaspora in the u s mexico borderlands it presents a fresh perspective on immigration nationalism and racism through the experiences of chinese migrants in the region during the late nineteenth and early twentieth centuries navigating the interlocking global and local systems of migration that underlay chinese borderlands communities the author situates the often paradoxical existence of these communities within the turbulence of exclusionary nationalisms the world of chinese fronterizos borderlanders was shaped by the convergence of trans pacific networks and local arrangements against a backdrop of national unrest in mexico and in the era of exclusionary immigration policies in the united states chinese fronterizos carved out vibrant enduring communities that provided a buffer against virulent sinophobia this book challenges us to reexamine the complexities of nation making identity formation and the meaning of citizenship it represents an essential contribution to our understanding of the us mexico borderlands

their photograph a firsthand look at how modern u s border policy has affected the people in the region from migrant workers to indigenous people to border patrol agents to residents of economically stagnant towns just north of the boundary the result is a travel memoir with a conscience an extension of thompson s ongoing work to humanize the hotly debated region the news observer

in 1821 mexico was geographically the largest country in the western hemisphere by 1853 however it was but a quarter of its original size meanwhile its neighbour north of the border had expanded its territory enormously and mostly at mexico s expense similarly in 1800 mexico s per capita income was half that of the united states by 1877 it had dropped to one tenth such asymetries have long characterised the relationship between mexico and the united states

the critically acclaimed 110 minute film alambrista 1977 depicts the harsh realities of mexican life on both sides of the border for this release a group of scholars has packaged a new director s cut of the film with a book of essays devoted to immigration and the u s mexican borderlands and an enhanced cd of the sound track

in this history of the social and human sciences in mexico and the united states karin alejandra rosemblatt reveals intricate connections among the development of science the concept of race and policies toward indigenous peoples focusing on the anthropologists sociologists biologists physicians and other experts who collaborated across borders from the mexican revolution through world war ii rosemblatt traces how intellectuals on both sides of the rio grande forged shared networks in which they discussed indigenous peoples and other ethnic minorities in doing so rosemblatt argues they refashioned race as a scientific category and consolidated their influence within their respective national policy circles postrevolutionary mexican experts aimed to transform their country into a modern secular state with a dynamic economy and central to this endeavor was learning how to manage racial difference and social welfare the same concern animated u s new deal policies toward native americans the scientists border crossing conceptions of modernity race evolution and pluralism were not simple one way impositions or appropriations and they had significant effects in the united states the resulting approaches to the management of native american affairs later shaped policies toward immigrants and black americans while in mexico officials rejected policy prescriptions they associated with u s intellectual imperialism and racial segregation

the editors of this collection of sixteen articles argue the relationship between the united states and mexico is at its most tenuous in recent memory each article explores the future of us mexico relations focusing on relevant topics such as trade water drugs health immigration environmental issues and security employing a strategic foresight methodology the authors use past trends and identify pivotal drivers to predict based on indicators at least three possible outcomes for the next few decades a baseline or continuity scenario an optimistic version and a pessimistic one they also articulate the implications each forecast has for both nations most chapters are co written by a scholar from the united states and another from mexico while acknowledging it is impossible to predict the future they nonetheless describe what could occur ultimately the authors of the articles in this fascinating volume make recommendations to achieve a peaceful integrated and prosperous north america that will drive the world economy the book is required reading for anyone interested in the binational relationship and the well being of citizens in both countries

mexico and the united states exist in a symbiotic relationship mexico frequently provides the united states with cheap labor illegal goods and for criminal offenders a refuge from the law in turn the u s offers mexican laborers the american dream the possibility of a better livelihood through hard work to supply each other s demands americans and mexicans have to cross their shared border from both sides despite this relationship u s

immigration reform debates tend to be security focused and center on the idea of menacing mexicans heading north to steal abundant american resources further congress tends to approach reform unilaterally without engaging with mexico or other feeder countries and disturbingly without acknowledging problematic southern crossings that americans routinely make into mexico in run for the border steven w bender offers a framework for a more comprehensive border policy through a historical analysis of border crossings both mexico to u s and u s to mexico in contrast to recent reform proposals this book urges reform as the product of negotiation and implementation by cross border accord reform that honors the shared economic and cultural legacy of the u s and mexico covering everything from the history of anglo crossings into mexico to escape law authorities to vice tourism and retirement in mexico to today s focus on mexican border crossing immigrants and drug traffickers bender takes lessons from the past 150 years to argue for more explicit and compassionate cross border cooperation steeped in several disciplines run for the border is a blend of historical cultural and legal perspectives as well as those from literature and cinema that reflect bender s cultural background and legal expertise

in the past two decades changes in the mexican government s policies toward the 30 million mexican migrants living in the us highlight the importance of the mexican diaspora in both countries given its size its economic power and its growing political participation across borders this work examines how the mexican government s assessment of the possibilities and consequences of implementing certain emigration policies from 1848 to 2010 has been tied to changes in the bilateral relationship which remains a key factor in mexico s current development of strategies and policies in relation to migrants in the united states understanding this dynamic gives an insight into the stated and unstated objectives of mexico s recent activism in defending migrants rights and engaging the diaspora the continuing linkage between mexican migration policies and shifts in the us mexico relationship and the limits and possibilities for expanding shared mechanisms for the management of migration within the nafta framework

the southwestern border is one of the most fascinating places in america a region of rugged beauty and small communities that coexist across the international line in the past decade the area has also become deadly as illegal immigration has shifted into some of the harshest territory on the continent reshaping life on both sides of the border in hard line ken ellingwood a correspondent for the los angeles times captures the heart of this complex and fascinating land through the dramatic stories of undocumented immigrants and the border agents who track them through the desert native americans divided between two countries human rights workers aiding the migrants and ranchers taking the law into their own hands this is a vivid portrait of a place and its people and a moving story of the west that has major implications for the nation as a whole

focuses on the modern mexican american borderlands where a boundary line seems to separate two dissimilar cultures and economies

a jewel to those interested in ore mining mineral collecting and mineralogy or the anthropology of value american ethnologist anthropologist elizabeth emma ferry traces the movement of minerals as they circulate from mexican mines to markets museums and private collections on both sides of the united states mexico border she describes how and why these byproducts of ore mining come to be valued by people in various walks of life as scientific specimens religious offerings works of art and luxury collectibles the story of mineral exploration and trade defines a variegated transnational space shedding new light on the complex relationship between these two countries and on the process of making value itself a novel contribution to the anthropology of natural resources journal of latin american and caribbean anthropology highly recommended choice

transborder media spaces offers a new perspective on how media forms like photography video radio television and the internet have been appropriated by mexican indigenous people in the light of transnational migration and ethnopolitical movements in producing and consuming self determined media genres actors in tamazulapam mixe and its diaspora community in los angeles open up media spaces and seek to forge more equal relations both within mexico and beyond its borders it is within these spaces that ayuujk people carve out their own at times conflicting visions of development modernity gender and what it means to be indigenous in the twenty first century

Your responsibilities include: Recognising when something has gone wrong: This involves self-reflection and honest assessment of your actions and those of your team.
